2016/2017 SEASON PASS POLICIES, CONDITIONS & RELEASE

You are the privileged owner of a Season Pass or Spring Fling Pass. To make the system work, it is imperative all Pass holders follow these simple rules and agree in writing to be bound by the policies and conditions on this application. The term "user" as used throughout this RELEASE includes, but is not limited to skiers, snowboarders, mountain bikers, hikers and any other recreational users, regardless of the season.

This season pass is a revocable license under the laws of Idaho and is revocable at the sole decision of the licensor, Schweitzer. The issuance of a pass authorizes the licensee to use related recreational amenities at Schweitzer Mountain in Bonner County, Idaho. The licensee agrees that they do not and shall not claim at any time any interest or estate of any kind or extent whatsoever in Schweitzer or its premises by virtue of this license or use hereunder.

- 1. In issuing this season pass, Schweitzer Mountain Ski Operations LLC, dba Schweitzer, makes no guarantees as to opening date, days of operation, or lifts and trails in operation. Refunds, exchanges or transfers will not be given due to late opening, early closing or conditions. The buyer of a season pass assumes all risk of a marginal snow year or inclement weather in summer.
- 2. Season Passes are NON-TRANSFERABLE and may not be resold. Fraudulent use or violation of any Federal, State, or local laws or Schweitzer area policies may result in pass cancelation without refund and/or civil or criminal charges. Schweitzer has the right to revoke privileges at its own discretion for any reason, including but not limited to inappropriate behavior, violations of ski area boundary policy (failure to use open gates), ducking ropes, failure to observe/obey signage, etc. Purchaser agrees to display season pass at all times when accessing Schweitzer property and lifts.
- 3. <u>Passes are NON-REFUNDABLE AND NOT SUBJECT TO CREDIT</u> except under limited conditions when Schweitzer Pass Protection has been purchased (not available on Spring Fling, Nordic passes or pass add-ons). See Schweitzer Pass Protection policy for specifics.
- 4. <u>Lost Season Pass</u>: If your Season Pass is lost or stolen, you must report it to the Schweitzer Season Pass office immediately. Do not use your season pass if you find it, until you have notified the Schweitzer Season Pass Office and have been cleared to use it. *A charge of \$25.00 will be made for reissuing a new pass*.
- 5. <u>Forgotten Season Pass</u>: Only two (2) day tickets will be issued for the entire season the pass is valid. *After 2 free replacement tickets have been issued a day ticket purchase will be required for each time forgotten.* If your ticket or Season Pass is found on another person, you will lose your pass privileges for the remainder of the season with no compensation and/or be subject to civil fines.
- 6. I expressly assume the risk of and legal responsibility for any injury to person or property that results from participation in the sport of skiing, snowboarding, as well as other activities, including any injury caused by the following, all whether above or below snow surface: variations in terrain; any movement of snow including, but not limited to, slides, sloughs or avalanches; any depths of snow, including tree wells, or any accumulations of snow, whether natural or man-made, including snowmaking mounds; freestyle terrain; surface or subsurface snow or ice conditions; bare spots, rocks, trees, other forms of forest growth or debris, lift towers and components thereof; utility poles, and snowmaking and snowgrooming equipment which is plainly visible or plainly marked. I agree to RELEASE, HOLD HARMLESS, AND INDEMNIFY SCHWEITZER MOUNTAIN SKI OPERATIONS LLC, ("SCHWEITZER"), ITS OWNERS, AFFILIATES, AGENTS AND EMPLOYEES from all claims for any cause, including negligence, which arises out of participation in skiing, snowboarding, summer activities and all related activities; including, but not limited to, use of indoor or outdoor facilities, Schweitzer Snowsports School programs and travel to and from Schweitzer Mountain, or travel to and from Schweitzer Snowsports School.
- 7. In consideration of using Schweitzer's facilities, I CONTRACTUALLY AGREE that ALL claims for injury and/or death shall be GOVERNED by IDAHO LAW and EXCLUSIVE JURISDICTION shall be in state court with venue in Bonner County Idaho.

2017 UCA REC SKIING/SNOW BOARDING P.E. Program

Information / Assumption of Risk Form

General Enrollment & Participation Information

Two (2) P.E. credits may be earned by students who participate in the Rec Ski/Board class for a minimum of five (5) UCA Rec Ski trips (see the UCA 2016/17 Calendar for scheduled ski dates).

Important Notice about P.E. Credit and Insurance

Students enrolled in the UCA Rec Ski program are only participating in the program when they travel with UCA or with parents on scheduled class ski dates. If a student who is enrolled chooses to drive themselves or ride with peers, they are not considered to be participating on that day. They will not receive P.E. credit for their attendance. They are not covered by any school insurance for that ski day. They will not be allowed to ride back on the bus after riding with peers to the mountain, with few exceptions.

Absences & Cancellations

There are inherent risks associated with enrolling in the UCA Rec Ski/Board Program. Ski days may have to be cancelled due to weather and/or lack of snow. Also, students may need to choose between conflicting activities on scheduled ski days.

Schweitzer Mountain Season Passes

Schweitzer Mountain season passes may be purchased through UCA until September 23, 2016. Passes may also be purchased at Schweitzer Mountain or online at the mountain website, http://www.schweitzer.com. Daily mountain lift tickets are not available through UCA. You may buy them directly from Schweitzer. Rental equipment may be rented at the mountain.

Non-Refundable UCA Enrollment Fee

The nonrefundable UCA Enrollment Fee for the 2016-17 ski season is \$250 (the fee is subject to change with prior notice). The fee covers vehicle fuel, maintenance, and staff supervision but does not include ski lift passes or rentals. The Enrollment Fee for students who ride with their parents is \$50. The Enrollment Fee may be partially refunded only in the case of a physician's/UCA school nurse's order for medical reasons.

Paying For the Rec Ski P.E. Program – 4 Options:

First Option — Enrolling & Traveling with UCA Each Week: Due on or before September 23, 2016, pay the total amount for a Schweitzer Season Pass and UCA fees all at one time, (Schweitzer Pass cost, \$220.77) + (UCA fees, \$250.00) = \$470.77.

Second Option - Enroll & Travel with UCA Each Week - Split your payment into two payments:

- 1. Payment # 1. Due on or before Sept 23, 2016, pay (Schweitzer Pass cost, \$220.77) + (Non-refundable UCA deposit, \$50.00) = \$270.77. (When you enroll in Rec Ski, the deposit will be deducted from your \$250.00 UCA Enrollment Fee.)
- 2. Payment #2. Pay \$200.00 before January 6, 2017.

Third Payment Option – Enroll in Rec Ski, But Be Driven by Parents Instead of UCA Bus/Vans (Students May Not Drive Themselves to Schweitzer) Students may travel to the mountain under parental supervision, but students may not drive themselves. To enroll in Rec Ski and travel with your parents each week: Return the signed Personal Transportation section of the Assumption of Risk Form, and pay \$270.77, (Pass cost, plus \$50). Students must be present and participate on a minimum of 5 class ski dates with the class in order to earn P.E. credit.

Fourth Payment Option – Day Skiers: Students Who Do Not Wish to Enroll For P.E. Credit But Who Wish to Travel with Rec Ski for a Ski Day.

Students who wish to ride with UCA Rec Ski for one day may turn in a signed **Day Skier Permission Form** and pay \$35 per trip. No P.E. credit may be earned for participation in this manner. On any given week, there may or may not be room to take extra people who are not enrolled in the Rec Ski Program.

Day Students/Parents Please Note:

- If your child is meeting the bus along the route to Schweitzer, you must drive them to the drop off, or provide a signed note giving permission for them to drive themselves to that point each week. (They may not drive themselves to Schweitzer.)
- Sack meals from the cafeteria can be provided for your child for both breakfast and lunch, but you will be charged for the meals.

General Enrollment / P.E. Credit Checklist

- Helmets are required. You must bring or rent one, and wear it.
- Sign and return this completed Assumption of Risk Form.
- Buy a Schweitzer Mountain season pass \$220.77 with UCA fee \$50.
- Before 1/6/2017, pay \$250.00 non-refundable UCA Enrollment Fee prior to first scheduled ski trip.
- Participate in at least five (5) UCA Rec Ski/Board trips using approved transportation.
- Fee Total: \$220.77 + \$50 + \$200 = \$470.77
